Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN PUERTO RICO, ALASKA, HAWAII AND WHERE PROHIBITED BY LAW. OPEN TO LEGAL U.S. RESIDENTS 18 YEARS OR OLDER.

ELIGIBILITY. The Victor's Holiday Adventure Sweepstakes (the "Sweepstakes") is open to legal residents within the 48 contiguous United States and District of Columbia who are at least eighteen (18) years of age at the time of entry. Entry in the Sweepstakes does not constitute entry into any other promotion, contest, or sweepstakes, whether sponsored by the Sponsor or otherwise.

HOW TO ENTER. There is NO PURCHASE NECESSARY to participate in the Sweepstakes. A purchase does not increase your chances of winning. By entering the Sweepstakes and/or posting to Sponsor's Facebook or Instagram post announcing the Sweepstakes, participants agree to accept and be bound by these official rules. Any decisions made by the Sponsor in relation to the Sweepstakes shall be final and binding. Eligible persons wishing to enter the Sweepstakes can do so through the methods described below: i. The Sponsor reserves the right, in its sole discretion, to disqualify any individual who interferes with or manipulates the entry process or attempts to enter contrary to these official rules. RANDOM PRIZE DRAWING; NOTIFICATION OF WINNER(S); ODDS. The Sponsor will randomly select **one (1) submission** from among all eligible entries received during the applicable Sweepstakes Period. The Sponsor will conduct its random selection of a winner for each Sweepstakes Period on or around January 6, 2021. The Sponsor's random selection of the potential winner is final and binding in all respects. The potential winner will be contacted via email by the Sponsor. The potential winner will be instructed to contact the Sponsor directly and provide the Sponsor with their contact information in order to receive the applicable prize. If a potential winner is disqualified for any reason, Sponsor will award the prize to an alternate winner randomly selected by the Sponsor among all eligible entries received.
